ear CLA members and supporters: As I wrap up four rewarding years as president and pass the gavel to Eric Lind, I'm pleased to report that China Lake Association heads into 2025-26 with fresh momentum. We are:

➤ In year 4 of our 10-year Watershed-Based Management Plan to cut phosphorus runoff

to cut phosphorus runoff and render phosphorus in lake bottom sediments inert through a future alum treatment while monitoring water-quality trends.

➤ Leveraging the Section 319 Clean Water Act grant

Partnerships with the Town of China and The Cottages on China Lake fixed a major shoreline runoff issue. At time of print, additional runoff issues were being resolved at Four Seasons Club.

> Strengthening shoreline buffers.

30 watershed property owners attended a buffer workshop in August, and more than 50 took home free native plants in June as part of our inaugural Buffer Bundle campaign, thereby improving the lake's natural phosphorus filter.

➤ Partnering with Maine DOT

to repair problematic culverts on roadways near the lake.

➤ Working with the China Regional Lakes Alliance

to expand Courtesy Boat Inspections and block invasive aquatic species. Your support powers every one of these efforts, with new projects already in the pipeline.

Enthusiastic Response to Buffer Bundle Campaign

If you offer it, they will plant it...

hat was the belief that organizers of the China Lake Buffer Campaign had in mind when they came up with a plan to give bundles of native plants to shoreline property owners.

Six months in the making, the project was coming to completion in mid-June as the phosphorous-filtering plants were distributed to property owners for immediate planting. The campaign is the brainchild of Jen Jespersen, owner of Ecological Instincts, an environmental consulting firm that has worked extensively with the China Lake Association and other lake conservancy groups.

It was a resounding success, with

more than 50 China Lake property owners quickly responding to the offer. "I'm amazed and pleased to see the response," said Jen Syer, a CLA director who was one of the planners of the campaign.

Syer called the campaign "a frictionless experience for landowners to help the lake."

Native trees, shrubs, perennials, and ground-cover plants were carefully selected by Jespersen's group for their buffering capability—stabilizing the shoreline, filtering stormwater, and helping protect the shoreline from

wave and ice damage. Valued at \$250, the bundles were offered free to participants. Property owners configured their selections to fit the landscape of their shorelines, with three different buffer bundle options based on site conditions. Syer said a waiting list has been created for those who weren't able to get the bundles this year. Free erosion control mulch was also provided as part of the bundles for interested landowners.

The China Lake Buffer Campaign is funded in part by a Section 319(h) Clean Water Act grant from the US Environmental Protection Agency, administered by the Maine Department of Environmental Protection. Other project support is provided by the Kennebec County Soil and Water Conservation District, China Lake Association, Kennebec Water District, and Kennebec Savings Bank, with technical support from Ecological Instincts.

Nest Platform Attracts More Than Loons

It looked like this could have been the year for hatching of a loon chick on the nesting raft built, maintained, and monitored by China Lake Association Director Bill Powell.

Powell, who saw his first loon rafts during childhood summers at his family's camp on a lake in New Hampshire, was excited in early May when loon-cam footage revealed an adult loon settling in on the moss and natural strawberry plants spread on the deck of the China Lake raft. A video of the would-be parent was a hit on the CLA Facebook page.

And then, for the third year in a row, things went sideways.

In past years, a loon pair has nested on the raft but failed to lay eggs. Another year, a loon pair nested and produced eggs—on shore 50 feet from the raft. Another year muskrats tore the raft nesting site to pieces.

This year it was a beaver that climbed aboard the raft and proceeded to eat all of the greenery, including the canopy of cedar boughs.

The loon video star was replaced by "birds, a beaver, and a muskrat," Powell said.

Undiscouraged, he points to the numbers: of the 83 rafts deployed in the state last year, 17 were nested on. Those nesting loons produced 20 chicks.

The risk to the young loons doesn't end there. Bald eagles are notorious for snatching chicks from the water, and a significant number die from being struck by boats.

Powell, who runs the Maine Audubon Loon Count on China Lake (Maine Audubon also provides funding and expertise for China Lake's raft effort), is determined to keep improving the loon nest platform in hopes that next year a loon chick will be the social media star.

"The raft is a perfect spot for a loon to nest," he said. "We'll continue to launch the raft in hopes of increasing our beloved loon population."

China Lake Water Quality Monitoring & Watershed Update

WD completed 17 sampling events (approximately every two weeks) between April and November 2024. Water Quality Technicians monitored a suite of water quality parameters within each basin of China Lake to provide insights into the conditions both at and below the surface of the water.

The parameters monitored included Secchi Disk transparency, water temperature and dissolved oxygen gradients, total phosphorus at multiple points in the water column, chlorophyll-A at the lake's surface, and zooplankton enumeration within the water column.

All the data collected throughout 2024 has been reported to Lake Stewards of Maine and the DEP for validation. A review of the data shows the slightly improving trends observed over the past decade within China Lake continue to hold true.

These primary trends, seen in the graphs provided, are an increase in the minimum, average, and maximum Secchi Disk transparency, continued periods of anoxia (absence of dissolved oxygen) at the deepest parts of the lake, and high levels of internal phosphorus recycling.

Throughout 2024, KWD managed and supported several projects, guided by the 2023 Water Stewardship Plan, to protect the water quality of China Lake. These activities included managing KWD owned forests around the West Basin of China Lake to maintain a healthy buffer to reduce the risk of pollutants entering the lake, increasing focus on education of people recreating on China Lake by improving signage and availability of educational materials at key locations around the lake, and








fully funding the China Lake Association Erosion Reduction Campaign utilizing a Maine Drinking Water Program Grant.

NOT Your Average Catch of the Day!

y grandfather has been fishing our local lakes for over 50 years. These days, he spends more time showing his greatgrandkids how to cast than worrying about what's on the end of the line. But last weekend, while he was trailering his boat out of a nearby lake (not China Lake), a Courtesy Boat Inspector flagged him down.

They pointed out a strange, stringy plant stuck on his propeller—something he'd never seen before. The Inspector said, "Something about this looks a little suspicious—just a small piece of an invasive plant can cause big problems for a lake. It's best to let the Maine DEP know, just to be safe. And always remember to clean, drain, and dry your boat and trailer before heading to a new lake. It really makes a difference!"

So Grampa clipped off a piece, brought it home, and followed the steps from Maine DEP. He floated it in a white tray, took a clear photo, and emailed it to milfoil@maine.gov with the date, his contact info, and name of the lake where the sample was taken. He kept it cool in the fridge. A couple days later, DEP got back to him and asked him to mail it in—so he did!

Turns out it was Eurasian milfoil! DEP thanked him, and he felt good knowing he helped prevent this incredibly invasive aquatic species from entering our favorite lake—China Lake, of course!

Jeremy Deeds: the Importance of Maine's 'Citizen Scientists'

rowing up in Windsor, Jeremy Deeds and his dad, John Deeds, fished China Lake, Three-Mile and Webber Ponds.

Now the younger Deeds, an aquatic ecologist with the State Department of Environmental Protection, is working to protect the water bodies that he enjoyed long before he became a scientist.

Deeds is the keynote speaker for the annual meeting of the China Lake Association, July 26 at China Primary School. His message: citizen scientists have and will be important to the study and stewardship of Maine's lakes.

After attending the University of Maine at Farmington, Deeds earned his master's degree from Kent State University in Ohio, and his Ph.D. from the University of Maine at Orono. He's worked as an environmental scientist in Pennsylvania and

Vermont, and sees that Maine has a distinct advantage over other states.

lake monitoring, done mostly by volunteers," Deeds said. "People are interested in the lakes and they're interested in how they work, and what affects them."

His presentation for CLA will center on an interactive lake-quality report card that he designed so that volunteers can assess a lake's water-and habitat-quality, and how it may be at risk. "We take the (citizen-generated) data across the state, and we can identify patterns and look at trends" Deeds said.

"We can get a better understanding of which lakes react a certain way to different factors in their water environment."
